Adoption of Agenda

Reports of the Officers

2018 Financials

Bylaw Amendments

New Bylaw: Severability

If any portion of these bylaws are declared invalid by a court of competent jurisdiction, or the Union of Taxation Employees bylaws and/or regulations, or the Public Service Alliance of Canada bylaws and/or regulations, then the invalid portion must be severed and the remainder of the bylaws are deemed valid.

Motion is carried.

New Bylaw: Return of Union Materials

- 1) Return of Union Materials On vacating their respective positions, all officers and stewards of the local shall deliver to their successor all documents, monies or other property of this union.
- 2) Return of union electronic materials/electronic access On vacating their respective positions, all officers and stewards of the local shall deliver forthwith all control and/or administrative right(s), including but not limited to passwords, login rights, access to all electronic and or social media accounts, websites, data storage devices, computers, computer systems to their successors of this local union.

Motion is carried.

New Bylaw: Oath of Office

1) The Oath of Office shall be administered to all officers before taking office Motion is carried.

Amendment to Bylaw 7: Meetings

Currently reads:

- 1) Annual General Meetings
 - a) The AGM of the Local shall be held before the last day of March of each year

Amendment proposed:

1) Annual General Meetings

a) The AGM of the Local shall be held on or before the last day of March of each year. Motion is carried.

New Bylaw: Non-Discrimination

- 1) The local and any person or other organization under the jurisdiction of the local shall not discriminate based against any person or group on any of the prohibited grounds as outlined in the Canadian Human Rights Act.
- 2) This section does not preclude any bylaw, policy, program, activity or group that has as its object the amelioration of conditions of traditionally underrepresented individuals or groups including the participation of Indigenous people, racialized people, people living with

disabilities, women, and people who identify within the LGBTQ2S+ spectrum, and will include any future changes to the groups respective naming or name changes.

3) Wherever in these bylaws a pronoun is used it refers equally, where the reference is applicable, to both men and women in the singular and the plural.

Amendment to Bylaw 12: Amendment to Local Bylaws

Currently reads:

- 1) A Notice of Motion of any amendment proposed must be posted for at least thirty (30) days prior to the date of the AGM, and that said proposed amendment(s) be dated on the day of posting, and witnessed by another party.
- 2) The text of the proposed amendment(s) must be included in the Notice of Motion posted.
- 3) A two-thirds (3) majority vote of the members present at the meeting shall be required to pass the amendment and, if passed, it shall be effective immediately.

Amendment proposed:

- 1) A Notice of Motion of any amendment proposed must be posted for at least thirty (30) days prior to the date of the Membership Meeting, and that said proposed amendment(s) be dated on the day of posting, and witnessed by another party.
- 2) The text of the proposed amendment(s) must be included in the Notice of Motion posted.
- 3) A two-thirds (³/₃) majority vote of the members present at the meeting shall be required to pass the amendment and, if passed, it shall be effective immediately.

Motion is defeated.
